These words imply that Jesus was God as well as the Messiah.

The lamp of the body is your eye. When your eye is sound, then your whole body is filled with light, but when it is bad, then your body is in darkness.

If your whole body is full of light, and no part of it is in darkness, then it will be as full of light as a lamp illuminating you with its brightness."

*Leader:* Who has been a light for you? (*Everyone should have time to share a time when someone was a light for them.*)

*Reader 2*: Let us pray, Emmanuel, Our world waits in darkness longing for Your light. In the midst of darkness, enkindle our hope.

### **Catholic Daughters of the Americas Bylaws**

Susan Moné, First Vice National Regent

Although our National Convention 2022 in Puerto Rico seems far away, it will be here before we know it. Now is the time to be planning for the pre-convention requirements and deadlines to be met in preparation for the Convention.

The Bylaw for our organization is one of those pre-convention considerations. Bylaws are the foundation for our organization to keep all members on track and to keep consistency within the entire membership. Bylaws are the written rules for the conduct of business in our organization. Bylaws are the framework for us to have a firm, strong organization.

Who can submit a proposed bylaw change? Bylaws may be voted on and submitted by.

1) Campus Court, 2) Local Court, 3) State Board, 4) State Court, 5) National Board, 6) National Bylaw committee. Bylaws for proposed changes can be found in our 2020 bylaw book on page 49, Article XXI.

The National Committee on Bylaws shall receive and review all proposed changes to the Bylaws. The Bylaws may be amended at any Biennial National Convention by a two-third (2/3) vote of the delegates present, provided written notice has been submitted to the Local and State Courts four months prior to the Convention. Note, it is possible that not all bylaws submitted will be brought to the floor by the Bylaw Committee at the Convention.

There is an exception for an emergency amendment to be proposed at a Biennial Convention without the 4-month prior notice if it has been approved by the National Bylaw Committee by three-fourth (3/4) vote of the full membership of the committee. The Bylaws may be amended by such an amendment only if approved at any Biennial National Convention by three-fourth (3/4) of the National Court present.

Approved amendments must be signed by the State Regent and State Secretary or by Local Regent and Recording Secretary. Local courts need to send a copy of the amendments prosed with the rational to the State Regent. An example of how to write a Bylaw can be found in the Tools of the Trade, Section 4, page 62, Attachment 23.

#### All proposed Bylaw Amendments must be postmarked by January 15, 2022.

## **Never Say Never**

Don't say you can't do it! Anyone, if you meet the qualifications, can be a National Director and really should give it a try! It is a very fulfilling obligation and you get to meet so many wonderful CDA sisters across this great nation. Read through the following qualifications, duties and guidelines and seriously think about running for a National Director position. Never say never—you can do it!

#### **Qualifications for a National Director**

Be a current and enthusiastic member of the Catholic Daughters of the Americas.

- Be a current or Past National Director, a current or Past State Regent, and a Catholic who publicly obeys the laws of the church and in accordance with these can licitly (in accordance with Church Law) receive the Eucharist. (Bylaw Article VI, National Court, Sec. 3C.)
- Be supported by her state court with a majority of the State Board giving written approval to endorse her as a candidate for National Director.
- Be able to respond promptly to all emails sent by members of the board or State/Territorial Regents. Your response can sometimes simply be "Got it" or "Thanks." This acknowledges that the email arrived at your address. "Reply" only, not "Reply All".
- Be computer literate and able to write reports on a computer.
- Be able and willing to travel to board meetings, state and national conventions, assigned state board meetings and the State and Territorial Officers Conference.
- Be able to make presentations to groups.
- Have knowledge of the current Bylaws and Tools of the Trade.
- It is not necessary, but strongly suggested, that at least your first term as State Regent be completed before applying for a National Director position in the Catholic Daughters of the Americas.
- Not more than two (2) members of the National Board shall be from the same state, with one as a National Officer and the other as National Director. (Bylaw Article VI, National Court, Sec. 3D)

#### **Duties of a National Director**

- Attend at least one board meeting a year of the state or territorial court under your jurisdiction, along with their state convention, and, attend and participate at one workshop. Permission must always be granted by the National Regent for travel which is to be reimbursed by national funds.
- Attend national board meetings twice a year and whenever a meeting is called by the National Regent.
- Maintain monthly communication with the State Regent in the states assigned to you, either verbally or in writing, and write geographical reports on each state and/or territorial court for each national board meeting. These reports are distributed at the national board meetings.
- Write articles for SHARE and the National Quarterly on topics assigned by the National Regent. The articles require approval by the National Regent prior to publication.
- Serve on or chair at least one committee of the national board and/or one area of the Circle of Love.
- Prepare a 45-minute to one-hour speech on national issues to be delivered at any state convention you attend. The contents of the speech require approval by the National Regent.

Complete other duties as assigned by the National Regent.

#### **National Board Guidelines (cont.)**

Serve as a representative in a supervisory capacity for states or territories assigned to you.

Keep all deadlines set by the National Regent or Committee Chairmen. Deadlines are set for a reason, strict adherence to deadlines will keep things running smoothly.

Render assistance, advice, instruction, when asked.

- Inform the National Regent of any problems in your states/territories as soon as they become known to you.
- Follow through on correspondence from National after speaking to the National Regent pertaining to Court problems. You will receive a copy of all communications sent from the National Office to your states. Follow up with the State Regent.
- Be familiar with State and/or Court programs.
- Encourage Membership Drives and promote National Programs.
- Assist the State Regents with Conventions, Installations and Receptions. Please remember the correct terms:
- Be prepared to speak on assigned topics.
- Send a copy of your board meeting report electronically to the National Secretary-Treasurer two weeks prior to the national board meeting and bring one copy to the meeting to be given to the National Regent once your report is given.
- Attendance at all National Board meetings is mandatory unless a valid excuse has been given and accepted by the National Regent.
- Contact the states that you have been assigned to supervise within thirty (30) days after receiving this information. At this time, you can introduce yourself and request information you will need as a State Supervisor.
- Contact your respective states within two weeks following each board meeting and relay information concerning dues, missing forms and other records needed by the National Office.
- If you are a new Board member, you must provide a certificate of participation in the Safe Environment program.
- When you receive an invitation to an event, it is your responsibility to respond at the earliest possible time. Invitations are not to be ignored. Before making any reservations for travel to visit states or to attend state or national functions, contact the National Regent for permission.
- Review the minutes of the previous meeting prior to the opening of the current meeting.
- Come prepared to present a three-minute oral report on the status of your states. This is to include areas of concern as well as areas of praise.
- Keep a phone log and copies of important emails and copies of all written communication with the board or your assigned states.

Whereas,	the goals and objectives of the JCDA program are divided into a Threefold Program of Message, Service, and Community including the motto "Be Useful" and a standard of "love God, serve others, live nobly," and
Whereas,	each Junior Catholic Daughter, having an active faith in God, experience personal and spiritual growth through liturgy, prayer and faith-based activities, and
Whereas,	each Junior Catholic Daughter participates in enriching lives through service to others in their family, parish, community and world following Christ's example, "What I have done, so you must do." (John 13:13-15)
Whereas,	opportunities be provided each Junior Catholic Daughter a lifelong journey leading to the development of leadership skills, therefore be it
Resolved,	each Junior Catholic Daughter seek meaningful behaviors with Joy and gladness to fulfill the JCDA Program, and be it further
Resolved,	that Sunday, February 20, 2022 be observed as the Ninety Fourth Annual National Junior Catholic Daughters of the Americas Day.

In 2018 Mississippi passed a law protecting unborn children who are 15 weeks and older in their mothers' wombs. This LIFE-saving legislation was challenged and is going to be heard by the Supreme Court.

Dobbs v Jackson Women's Health could be the landmark case that overturns the Roe v Wade decision. The oral arguments will be heard on December 1, 2021, but the decision is expected in June 2022.

These next 9 months are critical for all of us as Catholic Daughters. We are being invited with the Respect LIFE office of the Archdiocese of New York to fast and pray on the 22<sup>nd</sup> of each month in the hopes that on the 50<sup>th Anniversary</sup> (January 22, 2023), Roe v Wade is finally overturned.
